## ATHLETICS DONOR:

UNDER NCAA RULES, A REPRESENTATIVE OF THE INSTITUTION'S ATHLETICS INTEREST

## AN ATHLETICS DONOR IS ANY INDIVIDUAL WHO:

- Made any type of contribution to the University or Athletics Department; Provided benefits (e.g. summer jobs) to prospective or enrolled student-athletes or their families; Participated as a varsity student-athlete at Seattle University
- As a representative of athletics interests, you must inform the SU Compliance Office of any potential concerns regarding WAC/NCAA infractions.
- ONLY Coaches and Athletics Department Staff may be involved in the recruiting process. An Athletics Donor cannot engage in the recruiting process.



## AS A REPRESENTATIVE OF SEATTLE UNIVERSITY ATHLETICS...

## YOU MAY...

- · Have contact with an enrolled student-athlete on campus
- Contribute to the Seattle University Athletics Association
- Continue already existing friendships with families of prospects, but you may not attempt to recruit the prospect
- Attend high school or two-year college athletic contests or other events where prospects may compete; BUT you may not contact the prospect or their relatives
- Provide employment for an enrolled student-athlete so long as the student-athlete is paid for work performed at the going rate of that employment and the hiring is not based on his or her athletic ability or reputation
- Contact the Seattle University Athletics Department if you have any questions about being a representative of SU Athletics
- Notify Seattle U coaches about prospects in your area that may be strong additions to our teams

## YOU MAY NOT...

- Be involved in the recruitment of a prospective student-athlete
- Provide gifts of any kind, including birthday or holiday card/gifts to a student-athlete or a prospective student-athlete
- Provide special discounts for goods or services to enrolled student-athletes or prospective student-athletes
- Contact a SU prospect (or their family members) in person or off-campus
- Write or telephone a prospective student-athlete or member of prospect's family.
- Correspond with prospective student-athletes via any social media platform
- Take any action to encounter high school, prep school or community college coaches to direct their prospects to SU
- Provide tickets to prospect or their family at no or reduced cost at any home or away athletic or non-athletic event
